The following items are being issued here for clarification, addition or deletion and have been incorporated into the Construction Documents and Project Manual, and shall be included as part of the bid documents (Woolpert), dated March 15, 2016. All Contractors shall acknowledge this **Addendum No. 1** in the Bid Form. Failure of acknowledgment may result in rejection of your bid. All Bidders shall be responsible for seeing that their subcontractors are properly apprised of the contents of this addendum

CLARIFICATIONS (questions/ responses)

- Question: Alternate #4, Sheet L.201 Could the infill around pole vault be concrete in lieu of asphalt? Response: YES
- 2. **Question**: Please confirm For Base Bid, fencing at both ends of the track will have to be removed and replaced with new fencing to allow for track milling.
 - Response: YES; (Refer to drawing L.100 KEYNOTE 'E' & drawing L.200 KEYNOTE 'G')
- 3. **Question**: Please confirm As discussed at the pre-bid meeting, there should be NO curb patching/repair included in the base bid. The extent of any existing damage will be assessed and addressed post bid.
 - Response: YES that's CORRECT
- 4. **Question:** The technical specification includes a section for soil treatment, 31 31 16. Where would soil treatment of this type be applied to this specific project?
 - **Response:** Not applicable to milling and resurface work. This is intended for soil sterilization when doing full depth profile application.
- 5. Clarify Contract time: Contract Time will be 90 days as discussed at the Pre–Bid meeting 3/22/16. The approximate date for Notice to Proceed = May 13 or 16 and Project Completion/End = August 12 thru15. See below; Supplementary General Conditions (SGC) Article 23 is modified to reflect the contract time of 90 calendar days. (Note: SPC-Article 23 is referenced on page 3 of the FORM OF PROPOSAL)

PROJECT MANUAL / SPECIFICATIONS

- Revise Supplementary General Conditions Article 23 (to read as follows)
 - 1. The Contractor shall commence work to be performed under this agreement on a date to be specified in a written order from the designer and shall fully complete all work within 90 consecutive calendar days from, and including said date. For each day in excess of the above number of days, the Contractor shall pay to the Owner the sum of one thousand dollars (\$1,000.00) as liquidated damages reasonably estimated in advance to cover the losses to be incurred by the Owner by reason of failure of said Contractor to complete the work within the time specified, such time being in the essence of this contract and a material consideration thereof.

MINORITY BUSINESS PARTICIPATION REQUIREMENTS

<u>Provide with the bid</u> - Under GS 143-128.2(c) the undersigned bidder shall identify <u>on its bid</u> (Identification of Minority Business Participation Form) the minority businesses that it will use on the project with the total dollar value of the bids that will be performed by the minority businesses. <u>Also</u> list the good faith efforts (Affidavit A) made to solicit minority participation in the bid effort.

NOTE: A contractor that performs all of the work with its <u>own workforce</u> may submit an Affidavit (**B**) to that effect in lieu of Affidavit (**A**) required above. The MB Participation Form must still be submitted even if there is zero participation.

<u>After the bid opening</u> - The Owner will consider all bids and alternates and determine the lowest responsible, responsive bidder. Upon notification of being the apparent low bidder, the bidder shall then file within 72 hours of the notification of being the apparent lowest bidder, the following:

An Affidavit (**C**) that includes a description of the portion of work to be executed by minority businesses, expressed as a percentage of the total contract price, which is <u>equal to or more than the 10% goal</u> established. This affidavit shall give rise to the presumption that the bidder has made the required good faith effort and Affidavit **D** is not necessary;

* OR *

<u>If less than the 10% goal</u>, Affidavit (**D**) of its good faith effort to meet the goal shall be provided. The document must include evidence of all good faith efforts that were implemented, including any advertisements, solicitations and other specific actions demonstrating recruitment and selection of minority businesses for participation in the contract.

Note: Bidders must always submit with their bid the Identification of Minority Business Participation Form listing all MB contractors, vendors and suppliers that will be used. If there is no MB participation, then enter none or zero on the form. Affidavit A or Affidavit B, as applicable, also must be submitted with the bid. Failure to file a required affidavit or documentation with the bid or after being notified apparent low bidder is grounds for rejection of the bid.
